The meeting was called to order at 3:00 PM
The minutes from the August meeting were approved.

## Honorary Degrees Committee

The committee drafted language for the Honorary Degrees Committee based on guidance from the Committee on Committees and the Senate Chair. Joe Little moved to approve the language. The motion was approved. The committee decided to wait on the emeritus question until it receives feedback from the Senate. The committee decided to defer to Barbara Wingo regarding the Sunshine Laws request.

## Dean/Department chair search procedures

The committee drafted language to modify the Dean/Department Chair search procedures. Joe Little moved to approve the language. The motion was approved.

## Senate Secretary

The committee drafted language to update the Senate Secretary's role and function to be a position appointed by the Senate Steering Committee and that the position is a non voting ex officio officer of the Senate. Joe Little moved to adopt the language. The motion was approved.

## Committee and Council absence policy

The committee drafted language to state that the current Senator absence policy also applies to Senators on Councils and Senate and Joint committees. Joe Little moved to approve the language. The motion was approved.

## Senator Vacancies

The committee drafted language to add temporary senator replacement procedures to the bylaws for senators who are on sabbatical or have class conflicts for up to two semesters. Joe Little moved to approve the language. The motion was approved.

## Inconsistencies

The committee will request that Barbara Wingo submit track changes of the inconsistencies in the Regulations, Constitution and Faculty Senate Bylaws to the committee members.

## New Business:

Tim Taylor suggested that the committee adopt a structure on the constitution committee where the committee elects a chair elect from the first year members to develop a succession of chair elect, chair and past chair to ease the transition between chairs.

Joe Little moved to adopt this proposal and add it to the October agenda.
The motion was approved.
The meeting adjourned at 4:23 PM.

Compensation Committee:
The Compensation Committee shall have six faculty members who shall represent a broad range of academic disciplines and units. The members shall be elected by the Faculty Senate from the Faculty at large to staggered three year terms. The committee shall elect its chair. The President shall appoint one administrative representative to provide needed information to the committee. The committee shall evaluate and report on compensation relative to peer institutions, raise procedures, raise results and salary structures at the University

Bylaw 2E (e):

Bylaw 2 E (e) When a vacancy in the Senate shall occur because an elected member takes a leave of absence or because of the extended illness or death or resignation of any elected member before the expiration of the term as an elected senator, the vacancy shall be filled by special election in the unit. Special elections shall be called promptly by the appropriate administrative officer, and it shall not be necessary to employ the nominating committee procedure. The person elected shall hold the seat for the remainder of the unexpired term. Temporary replacement Senators shall be elected or selected as prescribed in a unit's constitution or bylaws.

## INCONSISTENCIES IN REGULATIONS, CONSTITUTION

## AND FACULTY SENATE BYLAWS

A few inconsistencies exist between the UF Constitution and the Faculty Senate Bylaws. In addition, the Regulations and the UF Constitution are inconsistent in some places. Most significant are those differences that relate to tenure.

Other subtle inconsistencies also exist, such as incorrect references to various portions of the Constitution that are no longer correct. For example, both the Regulations and Bylaws reference Article III, Section 6 of the Constitution for information regarding committees, including the Committee on Academic Freedom. Actually, the current Article III, Section 6 contains information regarding tenure, not information relating to committees. Finally, both the Constitution and the Bylaws continue to refer to University "rules" rather than "regulations." The inconsistencies are illustrated in the chart below.

Please draft language for the Compensation Committee based on the following
recommendations:

1. The Compensation Committee will be a Senate Standing Committee
2. The Compensation Committee will report to the Welfare council
3. The Compensation Committee will have 6 members who shall be faculty members representing a broad range of academic disciplines and units.
4. The Committee members shall be elected to staggered three-year terms by the Faculty Senate from the faculty at large
5. The committee shall elect its own Chair
6. The committee shall have one administrative representative appointed by the President or President's designee to serve as a non-voting ex-officio member able to provide the required information to carry out the committee's responsibilities
7. The committee will have the responsibility of the following tasks:

Monitor UF compensation relative to peer institutions
Monitor raise procedures at UF
Monitor raise results and salary structures at UF

Re: Process to replace senators for one or two terms

In the past year the Senate leadership has worked to improve Senate participation by keeping track of attendance at meetings; stressing the importance of Senate attendance to senators, their chairs and deans; and writing to all senators thanking them for their service and acknowledging the number of Senate meetings they have attended. Through this process we have come to discover that a fair number of senators are unable to attend meetings for one or two semesters because of teaching conflicts or sabbaticals.

The Constitution allows for short term replacements during absences from the University, but does not specify a replacement process, nor does it allow for absences for scheduled teaching conflicts. It says, "Absence from three consecutive meetings of the Senate constitutes resignation from the Senate, except that a Senator whose term is interrupted by a temporary absence from the University may be replaced on a temporary basis during that absence." (Emphasis added.)

Through this memo I am requesting that the Constitution Committee consider a simple process which will allow colleges to replace senators for one semester or one year due to absences from the University, and to create a document outlining the process. Additionally please consider the possibility of extending this temporary replacement policy to senators with short term teaching conflicts.

In order to implement your recommendations as early in the 2006-07 academic year as possible, please propose policy language by October 1, and be prepared to amend the Constitution, if you believe it is appropriate, to accommodate teaching absences, by December 1, 2006.

Subject: Honorary Degrees, Distinguished Alumnus Awards and Memorials Committee

In reviewing the functions of the HDDAAM Committee with representatives from the President's office, I thought it made sense to make a few changes to the structure and function of this committee. I will list the changes and would ask that you let me know if your committee approves of them in time to get them before the Senate for the September (information) and October (action) meetings.

1. Change the name of the committee to the Honorary Degrees, Awards, and Memorials Committee - this reflects the fact that the committee currently reviews Honorary Degrees, Distinguished Alumnus and Distinguished Achievement Awards, the Stephen C. O’Connell Distinguished Service Award, and namings for University buildings.
2. Change the committee from a Senate Standing Committee to a Joint Committee to reflect that only Honorary Degrees come before the Senate. Committee recommendations for the other awards and memorials go directly to the President and the Senate has no involvement in those.
3. Change the composition of the committee from 8 elected faculty members, to 6 elected faculty members (elected by the Senate) and 3 members appointed by the President. Currently the President has 4 administrative ex-officio non-voting members. The new presidential members would be voting members.
4. Specify that the definition of "faculty members" who are currently excluded from receiving Honorary Degrees include emeritus faculty.
5. Have all nomination packets go to the President's office where minutes and records of the committee will be kept for public records purposes, in keeping with the proportion of Senate to presidential functions.
6. Change the Constitution and By-laws accordingly to make this a Joint Committee, change the composition, and clarify the functions and procedures for nominations.

I look forward to receiving your committee's comments about these recommendations at your earliest convenience. Thank you for your consideration of these matters.
