Senate Council on Research and Scholarship Statement on 1UFResearch and IDC Distribution For Presentation to the Faculty Senate on May 4, 2006

The 1UF-Research plan will make research policy and administration uniform across campus by July 2006. It is part of the 1UF plan proposed by President Machen to make administration and business practices and policies more uniform across campus. Included will be a uniform method for IDC distribution to Colleges, Departments, and Pls' research programs.

In response to the charge by the Chair of the Faculty Senate, the Senate Council on Research and Scholarship has reviewed carefully the issues of 1UFResearch and IDC Distribution, and offers the following statement of principles:

- 1. Research is a key responsibility for most University of Florida faculty members, and the direct distribution of IDC to faculty PIs plays an important role in promoting and sustaining research across campus.
- 2. IDC also plays an important role in supporting new research initiatives across campus that are interdisciplinary and involve faculty across colleges.
- 3. The Council on Research and Scholarship is the appropriate Senate Council on the issue of the distribution and use of IDC.
- 4. A consistent plan for IDC distribution across campus to PIs, Departments, Centers, and Colleges facilitates cross-unit collaborations.

In light of these principles, the Senate Council on Research and Scholarship has set forth the following guidelines for IDC distribution across campus:

- 1. All academic units (Departments, Centers, and Colleges) will be treated fairly and equitably.
- 2. The IDC distribution policy will encourage rather than impede cross-disciplinary research and inter-college collaboration.
- 3. IDC will be used to support research and to improve the research competitiveness of the University of Florida, as mandated by state law.
- 4. IDC funds distributed to PIs, Departments and Centers will be maintained for support of research by PIs, Departments and Centers, respectively. The expenditure of these funds is not time-limited.
- 5. IDC funds used for special initiatives will be clearly identified as such, and amounts and justification will be reported to the faculty through the Senate.
- 6. IDC funds remaining after covering the costs of research infrastructure and services, special initiatives, and distribution to PIs, Departments, and Centers, will be distributed to Colleges in proportion to what their faculty generated.
- Charges to academic units for infrastructure and services will be equitable, based on usage where practical; the method for determining these charges will be transparent.
- 8. The Senate Council on Research and Scholarship will annually review and report on IDC distribution in line with these principles and guidelines.
