RE: College of Education Reorganization

One of the fiscal contingency plans developed by the College of Education at the end of the 2007-2008 academic year addressed possible reorganization within the College. The possible change in structure came about in response to budget reductions made at that time. Dean Catherine Emihovich worked with College of Education Faculty Policy Council to establish a Task Force on College Restructuring. Fourteen faculty, one staff member, and one doctoral student served on the Task Force, led by Professors Jamie Algina and Dorene Ross. The group examined restructuring issues and considered reorganization options. Task Force deliberations resulted in two plans for further consideration. Both plans offered a three "School" model with different alignments of academic programs. The Task Force voted on the plans and one plan emerged with overwhelming support (15 acceptable and 1 unacceptable, including the votes of the Task Force co-chairs).

The purpose of this memo is to seek approval of the new structure and School names so we may initiate necessary adjustments to university websites, documents, etc. Further, committees of the COE Faculty Policy Council, as well as faculty groups in the three proposed units, worked through the 2008-2009 academic year to create and approve changes to the College constitution, tenure and promotion procedures, merit allocation methods, and the like.

The 5 previous units were:

Department of Educational Administration and Policy (EAP)
Department of Counselor Education (CE)
Department of Educational Psychology (EP)
Department of Special Education (SE)
School of Teaching and Learning (STL)

The proposed 3 new units:

School of Human Development and Organizational Studies in Education School of Special Education, School Psychology, and Early Childhood Education School of Teaching and Learning

The tables below show the alignment of academic programs with the three proposed units. The former departments also are identified. One benefit of the proposed reorganization is a relatively equal distribution of programs, students, and faculty across units that did not exist previously.
