Faculty representatives may have several different levels of involvement in decision-making at the university. All must be understood as limited by state law and the authority or authorities to which the President of the University reports, and by contractual agreements between the University and individuals or a Union. Faculty representatives may *determine*, *recommend*, *consult*, or *receive timely information*.

To *determine* is to make the final decision on a matter.

To *recommend* is to make a decision that will not be reversed by the University Administration without an explanation of the reasons for the reversal, an opportunity for the faculty representatives to make counter arguments, and an effort to reach a resolution satisfactory to both parties.

To *consult* is to participate in the decision-making process with members of the Administration, and especially to be informed as to what the proposed decision is, and the rationale for that decision, *before* the decision becomes final.

On all issues affecting university policies and the university environment, the faculty and its representatives are entitled at least to *receive timely information*. The faculty should never be dependent solely on news media for information about matters of university governance.UF Faculty Senate Authority and Committees
